## IT'S TIME FOR MANY UFCW 951 MEMBERS TO COMPLETE OPEN ENROLLMENT FOR 2018 HEALTHCARE

Open enrollment for healthcare benefits has begun, or will begin shortly for many UFCW 951 members. It is important that members who wish to participate in these union negotiated health plans enroll by the deadline to ensure coverage for themselves and their eligible dependents.

### **Kroger Members**

Members at Kroger will be moving from the Michigan UFCW Unions and Employers Health and Welfare Fund into the Heartland Fund for benefits starting in 2018. Kroger members who are eligible for benefits in 2018 will receive a packet of information for open enrollment in mid-November. Open enrollment begins on November 12, 2017 and ends on December 11, 2017. Eligible members must complete open enrollment to receive benefits in 2018.

### **UFCW Health and Welfare Fund Participants**

Members at L.M. Foods and Harding's #383 and #400 who participated in the UFCW Health and Welfare Fund last year will be automatically re-enrolled for the same benefit coverage in 2018, provided that they have completed their biometric screening. Open enrollment for members who failed to complete their biometric screening, or who want to make a change from their 2017 coverage (i.e. add/remove a family member or update information) begins on November 14, 2017 and ends on December 5, 2017. These members must complete the enrollment process through the Health and Welfare fund to receive benefits in 2018. ### **Meijer Members**

Open enrollment ends on November 10, 2017 for eligible members who work at Meijer. Members should visit the Meijer Rewards site at [www.resources.hewitt.com/meijer](http://www.resources.hewitt.com/meijer) for information about plan options and to enroll.

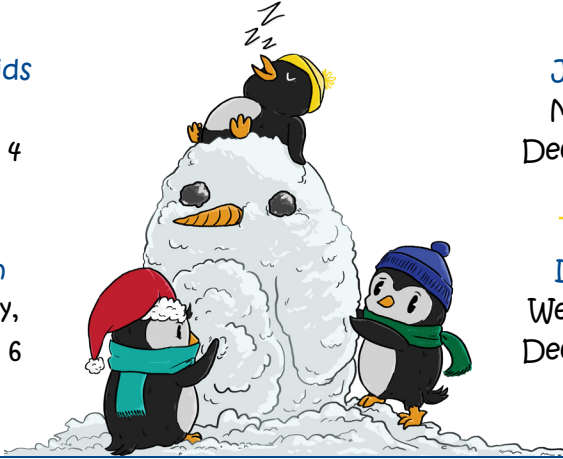
