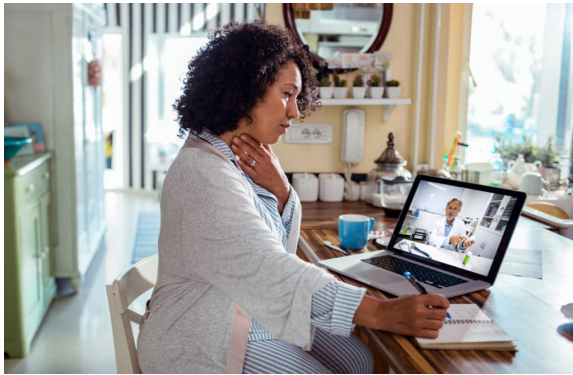

FREE TELE-HEALTH OPTIONS AVAILABLE TO MEIJER MEMBERS



Meijer members have access to free telehealth services through their Meijer health insurance plan as well as the company's Employee Assistance Program (EAP).

Online/virtual appointments are free for members enrolled in a health insurance plan through Meijer. Covered spouses, domestic partners and

dependents may also participate in free telehealth services. Telehealth visits may be facilitated through Blue Cross Online Visits, primary care physicians, specialists or other healthcare providers.

Blue Cross Online Visits are available 24 hours a day, and no appointment is needed for either child or adult medical visits. Blue Cross Online Visits for behavioral health needs, such as anxiety, grief or depression are by appointment only. Blue Cross Online Visits providers are board-certified doctors, therapists and other professionals. To access Blue Cross Online Visits download the BCBSM Online Visits app, call 844.606.1608, or visit bcbsmonlinevisits.com.

All Meijer members, including those who are not enrolled in a health insurance plan through the company, have access to free assistance with mental health and substance abuse issues, including virtual therapy sessions, through the EAP. These services are also available to others in the member's household. EAP services can be accessed at www.magellanascend.com or by calling 800.327.5480.

Online visits require video capabilities through your smartphone, tablet or computer.
