## NAVIGATION PARTNER BENEFIT CAN HELP MEMBERS MANAGE BENEFITS THROUGH THE STATE

In addition to partnering with the United Way, the UFCW 951 Community Services program is now working with the Michigan Department of Health and Human Services (MDHHS) to help members navigate MDHHS services through the MI Bridges online portal.



As a Navigation partner, UFCW 951 is now able to assist members who are also clients with DHHS by helping them complete the MI Bridges application, find resources, answer questions, keep track of important deadlines and help them coordinate with their case worker. Members who choose to share information about their benefits with the Navigator can control what information is shared, and are able to revoke access if they choose to do so.

UFCW 951 members who are interested in applying for state benefits but do not yet have an account with MDHHS or MI Bridges can create one by visiting [www.michigan.gov/mibridges](http://www.michigan.gov/mibridges), selecting 'Register', creating a username and password and completing the process to confirm their identity. Members who have an account with MI Bridges can connect with the UFCW 951 Navigator by logging in, selecting the 'Connect with a Navigator' link that is on the bottom of every page and entering the CP ID 7449-002. If you are having an issue with creating a username, verifying your identity, or are experiencing a technical problem with the MI Bridges site, contact the help desk at 844.799.9876
