UNDEREMPLOYMENT BENEFITS MAY BE AVAILABLE TO MEMBERS WHOSE HOURS ARE CUT

Members who have had their hours reduced by their employer and have been unable to pick up additional hours have the right to file for Underemployment Benefits through the State of Michigan.

Members who have had their hours reduced and are interested in applying for this benefit or who would like more information must contact the Michigan Unemployment Insurance Agency (UIA) at 1.866.500.0017 or visit their website at www.michigan.gov/uia.

Eligibility for Underemployment Benefits - as well as the amount of the benefit if it is awarded - can only be determined by the Michigan Unemployment Insurance Agency (UIA). To protect yourself from having your Underemployment Benefit claim denied, it is recommended that you inform management that you are available for any work they may have.

DON'T FORGET TO SUBMIT YOUR 2019 VACATION REQUESTS

Most UFCW 951 contracts contain a procedure for securing guaranteed vacation time during the year. Be sure to complete your vacation requests by the deadline as specified in your union contract.

Meijer members: There are no "blacked out" vacation weeks on the calendar. However, there are "grayed out" weeks, where a limited number of vacations will be granted.

TICKETS ARE NOW AVAILABLE FOR THE UFCW 951 PISTONS GAME



UFCW 951 is offering members discounted tickets to the Detroit Pistons vs. Indiana Pacers game on Monday, February 25 at 7:00 p.m. at Little Caesars Arena. Members can purchase Lower Bowl tickets for \$33 each for the first two tickets and \$48 each for additional tickets. (Tickets valued at \$50.) Lower bowl tickets include a Detroit Pistons logo item. Upper Bowl tickets can be purchased for \$18 each for the first two tickets and \$33 each for additional tickets. (Tickets valued at \$35.)

All tickets come preloaded with \$10 that can be used to purchase food at the arena and include a post-game shot on the court. The first 23 tickets purchased by members also come with the Pistons High Five Tunnel experience. For every ticket sold, the Pistons will donate \$5 to the UFCW 951 Foundation.

DEADLINE APPROACHING TO APPLY FOR THE UNION PLUS COLLEGE SCHOLARSHIP

The deadline to apply for the 2019 Union Plus Scholarship program is January 31, 2019. UFCW 951 members who have been in good standing for at least one year as of May 31, 2019, and their spouses and dependent children are eligible to apply for a scholarship of up to \$4,000 through Union Plus.
