MEMBERS AND THEIR GUEST CAN NOW RIDE BUS TO 2020 PISTONS GAME!

UFCW 951 is offering members discounted tickets to the Detroit Pistons vs. Charlotte Hornets game on Monday, February 10 at 7:00 p.m. at Little Caesars Arena in Detroit. All tickets come preloaded with \$10 to purchase food at the arena and include a post-game shot on the court. Lower bowl tickets also include a Detroit Pistons logo item. Members who purchase the first 18 drive-yourself-to-the-game tickets will get the Pistons High Five Tunnel experience. Bus transportation will be available from Grand Rapids and Lansing this year.

“The Pistons game has been a really popular event with our members for the past few years. Members have reached out and asked for bus transportation, either because they don’t have their own transportation to the arena, or because they live far away and don’t want to make the long drive and then have to pay for parking,” UFCW 951 President John Cakmakci said. “We are always open to member’s suggestions for new events or for ways to improve the events we already have. Thanks to input from our members, we have decided to offer bus transportation for next year’s Pistons game.”

Lower Bowl Tickets: \$33 each for the first two tickets
Additional tickets are **\$45** each (Tickets valued at \$51)

Upper Bowl Tickets: \$18 each for the first two tickets
Additional tickets are **\$30** each (Tickets valued at \$35)

Ride the Bus to the Game:

Lower Bowl Tickets: \$53 each ticket, max 2 tickets (Package valued at \$76)

Upper Bowl Tickets: \$38 each ticket, max 2 tickets (Package valued at \$60)

Members can purchase tickets online with a credit or debit card by visiting the UFCW 951 website at www.ufcw951.org/events. To pay with a check or money order, print a form from the UFCW 951 website or contact your union representative for a copy. **Orders MUST be received by Wednesday, January 1, 2020, but tickets could sell out before then.** For every ticket sold, the Pistons will donate \$5 to the UFCW 951 Foundation.
