\$250 C.A.R.E.S. GRANTS STILL AVAILABLE TO UFCW 951 MEMBERS AFFECTED BY CORONAVIRUS PANDEMIC



UFCW 951 will continue to offer \$250 C.A.R.E.S. Grants through at least December 2020 to help members remain financially stable as they cope with the effects of the pandemic on their lives.

To be eligible to receive a C.A.R.E.S. Grant, applicants must have been directly affected by the pandemic, i.e. they were diagnosed or had a member of their household diagnosed with COVID-19, lost a member of their household or an immediate family member to COVID-19 or were ordered to quarantine due to being exposed to someone who tested positive for COVID-19. Members may also qualify if they have been financially affected by the pandemic when a member of their household was laid off, their hours were reduced or they were unable to work due to personal health concerns, for example.
