UFCW Voluntary Payroll Deduction Authorization for Political Checkoff & UFCW 951 Foundation

I hereby voluntarily authorize my Employer to deduct an amount equivalent to one dollar (\$1) per week from my paycheck with such amount to be transmitted to the UFCW International Active Ballot Club and/or one dollar (\$1) per week from my paycheck with such amount to be transmitted to the UFCW 951 Foundation, at such time and in such manner as may be agreed upon by my Employer and UFCW Local 951.

I understand that these authorizations are voluntary and that the amount suggested as a contribution is a guideline and that I may contribute more or less than this amount by any lawful means, other than this checkoff, or may refuse to contribute, and that making payments to the UFCW Active Ballot Club and/or the UFCW 951 Foundation is not a condition of membership in the Union or of employment with the employer and that I have a right to refuse to sign this authorization without reprisal.

I understand that my contribution to the Active Ballot Club will be used for political purposes, including the support of candidates for federal office, and that my contribution to the UFCW 951 Foundation will be used for funding community based organizations that benefit working families.

I understand that contributions to the Active Ballot Club are not deductible as charitable contributions for federal tax purposes. I also understand that contributions or gifts to the UFCW 951 Foundation are deductible as charitable contributions for federal tax purposes. I expressly reserve the right to revoke either or both of these authorizations in writing at any time.
