KROGER CONTRACT NEGOTIATIONS TO BEGIN SOON

UFCW 951 will start contract talks with Kroger in early May, as the current contract expires on June 15, 2024. The local represents more than 1,000 workers at 10 Michigan Kroger stores. A bargaining committee, made up of members, will represent the union in negotiations and will focus on increased wages. Nationwide, recent contract talks between Kroger and other UFCW locals

have been contentious, as Kroger's main focus is a potential merger with Albertsons.

"Kroger brings in billions of dollars, and its workers are responsible for those earnings," Courtney Phillips, UFCW 951 secretary-treasurer and lead negotiator for the talks, said. "In these negotiations, Kroger should only be focused on how valuable its employees are to the company."

CONTRACT TALKS STARTING IN APRIL FOR MEIJER FRESH ASSEMBLY & GRANDVILLE NUT ROASTING

UFCW 951 will begin negotiations on April 12 for a new contract for the nearly 200 workers at Meijer Fresh Assembly in Lansing and the Meijer Grandville Nut Roasting plant. Workers at each facility are currently covered by separate contracts. These negotiations aim to create one contract for workers at both sites.

"The workers at both facilities deserve a substantial wage increase," Courtney Phillips, UFCW 951 secretary-treasurer and lead negotiator for the talks, said. "Unifying these manufacturing workers under one contract strengthens our bargaining power."

A bargaining committee, made up of members from both sites, will focus on wage-related issues. In February, members from both locations joined Meijer retail and distribution center workers in approving a Universal Benefits Agreement securing improvements in paid time off, leaves of absence, and retirement. The current Nut Roasting contract expires on May 18, 2024, and the current Fresh Assembly contract expires on August 2, 2025.
